Festival Information

The Capital Pride Street Festival, DC's largest annual one-day event, is celebrating its 44th year along iconic Pennsylvania Avenue and in front of the US Capitol.

- Throughout the day more then 300,000 people enjoy the annual free festival and the three stages, family area, local LGBTQ+ organizations & supporters, national headline entertainment, three beverage gardens and approximately 15 food vendors.
- Approximately 300 exhibit spaces line Pennsylvania & Constitution Avenues between 3rd and 7th Streets. The festival has a 75% return rate from past exhibitors and food vendors and has sold out each year since 2006.
- Parking is extremely limited at the festival. Exhibitors that need parking are encouraged to use Spot Hero to prepay and reserve a parking space or arrive early to find a metered spot in the area. Vendors CANNOT park on the festival site, including supply trucks, vehicles or anything that is outside of your 20'x20' footprint.
- The festival is a rain or shine event. As a nonprofit organization, registration fee refunds are not possible in advance or onsite.

NOTIFICATIONS - ACTION REQUIRED

ICE SALES: Registration link TBA.

Capital Pride will be the official ice vendor at the festival. As the official ice vendor, no other ice vendors may come onto the festival site. If you plan to bring your own ice, that is authorized. To order pre-sale ice at \$12.00 per 20lb bag, visit the link above; onsite ice, if available is \$30 per 20lb bag.

PROPANE PERMIT: https://dcwebforms.dc.gov/fems/permit1/

All vendors using propane must apply with DC Fire and EMS for a propane permit. Visit the site above to apply and pay for the permit. The fire marshal will not sell propane permits onsite and you will not be able to use propane without the permit. Vendors are allowed up to 200 lbs. per vending site; no individual tank is permitted to be larger than 60 lbs. The fire marshal will deliver the permits to your booth the morning of the festival.

If you have not already sent your COI (with Capital Pride listed as additional insured), you will need to do so by May 31th. Email is preferred, but you can mail to: Capital Pride, 2000 14th Street, NW, Suite 105, Washington, DC 2009; fax to 202-719-5304 or email festival@capitalpride.org. Failure to submit your COI is grounds for denial of festival participation with full loss of registration fees.

All vendors who are selling at the festival must file and pay sales tax to the Washington DC Government. Capital Pride will submit your information to the DC Government and your organization is responsible for submitting your sales tax to the DC Government.

Food vendor orientations are no longer mandatory and all information relating to special events and DOH compliance should be reviewed at http://doh.dc.gov/service/food-safety-hygiene-inspection-services-division. Health inspectors will be onsite and must inspect your area prior to your service.

ORIENTATION BY SHOW MANAGEMENT

Food vendors may attend (NOT mandatory) an optional festival exhibitor orientation. DATE AND LOCATION TBD. [Note: Parade orientation begins at 7:30pm following festival orientation.] The orientation is geared toward general exhibitors but if you have additional questions after carefully reading this document, you may join the festival portion from 6:30pm – 7pm. Alternatively, the presentation will be posted at www.capitalpride.com/confirmation after the meeting.

SUSTAINABILITY INITIATIVE

Capital Pride is recommitting to sustainability! This year, Capital Pride is expanding its "greening" program. Vendors and participating organizations are encouraged to consider their booth's environmental impact as they plan for the festival.

MERCHANDISE AND PROMOTIONALS

When possible, avoid distributing single-use plastic products like individually wrapped items, disposable water bottles, or balloons and beads. Alternative products can fulfill the same purposes. Consider branding items like reusable water bottles, reusable straws, plant seed packs, drink coasters, towels or sweatbands, bike pressure gauges, eco-tube lip balm, etc. All vendors are required to use earth-friendly packaging and bags (no plastic bags may be used). Failure to comply will result in a fine at the festival and/or removal from the festival.

LOCAL ENVIRONMENTAL ORDINANCES

The District of Columbia does not permit the distribution of plastic straws, plastic stirrers, or Styrofoam. (Plastic straws may be provided to accommodate persons with disabilities). The District of Columbia has a goal of reducing plastic waste by 80% by 2032—please help by reducing consumption and opting for plastic alternatives.

RECYCLING

Capital Pride will provide recycling bins throughout the festival site. Many recycling bins will be designated for commingled glass, plastic and aluminum containers. Other bins will be clearly marked as "paper only," including for collection of leftover Pride Guides that vendors may have at the end of the event. Cardboard is also recyclable and can be placed in bins adjacent to the chair and table locations or given to a recycling volunteer during set-up or break-down.

GET GREEN CERTIFIED

What's the benefit? Use less, waste less, pay less! Tell Capital Pride how you are taking efforts to be more environmentally friendly during the festival and receive a Certified Green Vendor poster to display at your booth. Take credit for "green" deeds and draw environmentally conscious festival patrons to your booth! Some steps may save you money, too

What do I have to do? Indicate ways that you "green" your booth (e.g., use recycled paper for all printing needs, use an e-mail list instead of handing out pamphlets, recycle during the Festival, or use biodegradable utensils). LOGISTICS

FOOD VENDOR space is 20'x20'. Space is extremely tight and you will have neighbors on both sides of your exhibit area so you cannot go outside your footprint.

- Capital Pride provides the location for each exhibitor. During arrival, look for your company name to be painted on the street. The festival production team will do it's best to honor preference requests, however, preferred space cannot be guaranteed. Management reserves the right to make changes to festival exhibits through onsite set-up.
- All participants are required to provide a clean and attractive appearance to their exhibit space and exhibitors are highly encouraged to decorate their space using this year's theme. This should include attractive signs, posters, decorations and tablecloths.

RECYCLABLES AND TRASH: Recyclables must be removed from trash; trash and recyclables must be brought to provided containers (at 3rd Street and 6th Street & Constitution). Food Vendors found putting trash into festival receptacles are in violation of their food vendor agreement and may be fined up to \$100 per incident.

FIRE LANE & FIRE HYDRANTS: There will be a 20' wide fire lane through the site. This fire lane must remain clear at all times during the festival - no exceptions!! You are not permitted to store items in the fire lane! Do not block fire hydrants.

GENERATORS: Food vendors MAY NOT hook into the existing generators throughout the site. Food vendor equipment is too much of a drain on those generators. If you need a generator, you can rent an individual generator from show management at \$400 for the day or bring your own.

- All participants must follow the laws and regulations of the Government of the District of Columbia. On the day of the festival, all participants must follow the guidance and instructions given by Festival staff and official personnel.

FINES: Due to feedback from festival participants and city officials, Capital Pride will enforce all rules and levy an onsite fine for violations. The two big issues mentioned have been price gouging and failure to keep a clean space, particularly boxes and other recyclable materials. Fines will also be levied for failure to contain your set-up and supplies in your designated 20x20 space.

BREAK-DOWN

Festival vending and Monument Court Food Vending ends at 7pm – DO NOT BREAK DOWN BEFORE 7PM. [Note: The Capitol Stage at 3rd Street will continue until 10pm.]

NOTE: Vehicles may not be allowed on Pennsylvania Avenue until as late as 9pm. The decision to allow vehicles is at MPD's discretion; management cannot influence the decision, as it's a safety and security factor.

- Vendors will be able to enter Constitution Avenue at 7th Street when permitted by MPD.
- Vendors are encouraged to bring carts or hand-trucks to move their materials from their booth to the pick-up zone at Constitution and 6th. Please note this is a quick drop zone and MPD may ticket or tow vehicles without drivers.
- Once MPD gives the all clear, exhibitors may enter the site on Constitution Avenue at 7th Street to clear Food Vendor Registrant Packet 2019

materials directly from their booth. Remember all vehicles on Constitution Avenue must proceed east (toward the Capitol). Vehicles may exit Penn Ave via 7th Street, 6th Street or 4th Street. Do not cause roadblocks by traveling in the wrong direction.

SET-UP

Food vendors may begin set-up as early at 8:30am on Sunday. Please do not arrive before 8:30am, as MPD will prevent you from driving onto the site due to the continued work of the festival builders and contractors.

You should be ready to serve at 12pm. The fire marshal and DOH inspector will inspect your space before 12pm. Vendors may not begin serving until cleared by DC officials.

If you plan to drive onto the site to pull up directly to your space, you MUST ENTER CONSTITUTION AVENUE FROM 7TH STREET AND ONLY PROCEED EAST (toward the Capitol). Marshalls will direct you to proceed east or west on Penn Ave.

All vehicles must be removed from the Festival grounds by 10:30am. THIS IS A MAJOR SAFETY CONCERN AND MPD WILL TICKET AND TOW VEHICLES STILL ON THE SITE. No vehicles are allowed onto the Festival Site until permission is given by the DC Police Department.

NOTE: Parking is not available at the site and limited parking is available in the area. Plan to arrive early if you will need a parking space. Be sure to note all traffic regulations and meters. Vendors may also try spothero.com to reserve and pay in advance for a space.
